

Instructions for Authors

Tiempo&Economía (T&E) is a biannual electronic journal published by the School of Economics and Administrative Sciences at the Universidad de Bogotá Jorge Tadeo Lozano. Its primary purpose is to publicize theoretical works and practical studies developed in Colombia, the region and worldwide on economic, business and entrepreneurial history, as well as on administrative, economic and accounting ideas. T & E is a plural and interdisciplinary journal that seeks to encourage discussion on theoretical and methodological advances that are produced regarding these issues and to encourage and enrich the debate within the academic community.

The Journal gives priority to the publication of original articles that are the result of scientific research on problems in economic and business history, specifically articles with a clear theoretical reference and, insofar as is possible, ones that include critical reviews on the state of the art. It also seeks to bring together researchers who are interested in the balance and development of the history of economic, administrative and accounting ideas. They will find an opportunity to make their work known through T & E.

The Journal's editorial team is comprised of a general editor, an associate editor, an editorial coordinator, a scientific committee, an editorial committee, and a group of reviewers, all of whom guarantee the quality and relevance of the contents of the Journal through their work. The members of the editorial team are evaluated annually according to their recognition in the area and their academic output, visible in other national and international indexed journals.

Material may be submitted for publication at any time.

Copyrights

The right to reproduce an article in printed or electronic form and the right to distribute it must be relinquished to the Journal by the author(s). This is a condition for its publication. The transfer of copyrights becomes effective once the article is accepted for publication, at which time the author will receive the respective waiver to sign. This means ownership of the right to reproduce and distribute the article, all translation rights thereof, as well as the right to publish the article in any format will be transferred to *Tiempo & Economía*.

The document may be reproduced freely for academic use, provided no one obtains a profit from doing so and as long as each copy includes a mention of the source, together with the other indications stipulated in the Creative Commons 4.0 license (<http://creativecommons.org/licenses/by-nc-sa/4.0/>).

The electronic edition provides open access to its contents through <http://goo.gl/AqOSnO> and in the specialized databases the Journal considers appropriate for its indexing.

In addition, the authors must guarantee their contribution is original and that they are responsible for the ideas expressed therein. They also must attest to the ethical suitability of the article. Authors must state explicitly that the text is of their authorship and that it respects the copyrights of third parties. If material that is not the property of the authors is used, it is their

responsibility to ensure they have authorization for the use, reproduction and publication of tables, graphs, maps and diagrams, among other elements.

Length and Format

Articles submitted for publication may contain no more than 9,000 words, including notes, tables, graphs, conclusions and bibliographic references. Abstracts may contain no more than 3,000 words.

Material submitted for publication is to be sent to the following email address tiempoyeconomia@utadeo.edu.co or through our OJS editorial management system at <http://goo.gl/AqOSnO>. The Journal accepts files in PDF, Word or LaTeX (including Scientific Word and Work-place). The file must contain all the material that is part of the article, including notes, graphs, tables and attachments. The authors must keep a copy of the electronic file that contains the version of the document submitted.

Contents of the Article

The article must contain:

- The title in the original language and its equivalent in English.
- The author's full name, or expressed indication of how the author usually signs his or her publications, so as to avoid duplications in databases. Preferably, the OrcID and Google Scholar registration number should be provided.
- Name of the institution with which the author is affiliated and the email (preferably the institutional one), and the city and country.
- An abstract summarizing the work, written in the original language with its equivalent in English and containing no more than 120 each.
- No more than five keywords in Spanish and English and their respective *Journal of Economic Literature* (JEL) classification. http://www.aeaweb.org/journal/jel_class_system.php
- The article should contain an introduction on the topic, a description of the methodology and a historiographical discussion of the topic, developed in a way that clearly indicates each of the sections, the conclusions and the bibliography.
- One the article has been accepted, expressed indication must be provided as to the sponsorship and/or institutional support, scholarship or project from which it arose or was part of.

Citation

T&E uses the APA (American Psychological Association) citation system. It is recommended authors consult the 6th edition of the *Publication Manual of the American Psychological Association*, which is the latest published version (<http://bit.ly/MVSEuq>).



Reference for a Periodical Publication

Surnames, A., Surnames, B. & Surnames, C. (date). Title of the article. *Title of the publication*, volume (number), pp. xx-xx. <https://doi.org/xxxxxxxxxxxx>

Example:

Ojeda, R. (2008). Abastecimiento de Santafé antes de la Independencia. A propósito de la tienda de Llorente. *Revista Tabula Rasa*, 8, 14-17. <https://doi.org/xxxxxxxx/xxxxx>

Reference for a Book

Surname, Initial of the author or publisher. (Year of publication).

Title of the book in italics (edition). Place of publication: Publisher.

Example:

Mares, D. (2001) *Violent Peace: Militarized Interstate Bargaining in Latin America*. New York: Columbia University Press.

Reference for Part of a Book

Surname, Initial of the author or publisher. (Year of publication).

Title of the chapter or section. In Publisher (with the name in normal order) (Publisher's abbreviation), *Title of the book in italics* (range of pages). City where the book was published: Publisher.

Example:

Urrutia, M. (2010). Precios y salarios en el siglo XIX. In A. Meisel and M. Ramírez (eds.), *Economía colombiana del Siglo XIX* (pp. 7-40). Bogotá: Banco de la República.

Academic Peer Reviewers:

To review the articles, suitable academic peers are convened in keeping with the topics addressed in the material submitted to arbitration. Their suitability will be confirmed by the Editorial Committee, according to the names submitted for its consideration by the Scientific Committee, the Editor and / or the Editorial Coordinator.

Initially, two (2) reviewers will be assigned to each article. If both approve its publication, the article is published with the corrections or changes suggested by the reviewers. If both object to its publication, the article will be rejected. If publication is approved by one reviewer and rejected by the other, a third reviewer will be appointed who will decide whether or not the article is suitable for publication.

In each of these three cases, the outcome will be reported to the author, omitting the name of the reviewer, who will remain anonymous.

Ethics and Best Practices

Tiempo & Economía adopts the principles of transparency and best practices described in the COPE Principles of Transparency and Best Practice in Scholarly Publishing in 2015. Accordingly, it is committed to observing and respecting ethical standards at every stage of the publication process and guarantees the publication of clarifications, rectifications and corrections when necessary.

The editorial team is comprised of an editor, an associate editor, a scientific committee, an editorial committee and an editorial coordinator. The members of this team are required to keep all articles received for publication confidential and to refrain from using data or interpretations in their own research until the article is published. This team reserves the right to decide on the publication of articles and the edition of the Journal in which they will appear.

Authors: Those who submit their articles for publication must comply with the ethical principles contained in the declarations and laws on intellectual property and copyrights of the specific countries where the research was conducted. Therefore, authors must complete and sign the authorization for arbitration, transfer of rights and the license for use that is available on the Journal's website. In it, the authors confirm their authorship and expressly indicate that the intellectual property rights of third parties are respected. In signing this authorization, the authors allow the Universidad de Bogotá Jorge Tadeo Lozano to make use of the respective property rights (reproduction, public communication, transformation and distribution), so the article can be included in the Journal.

Peer Reviewers

The peer reviewers are mostly external to the Universidad de Bogotá Jorge Tadeo Lozano and are selected objectively and impartially. They accept the COPE Ethical Guidelines for Peer Reviewers and are obliged to reject an invitation to review if they believe a personal or professional conflict of interest may exist. The review form, with the criteria to be assessed, is available on the digital platform of the Journal. It must be completed by the reviewer for the article he or she has agreed to review. The names of the authors and reviewers remain anonymous throughout the review process.
